- I, LANCE C. DAHL, hereby solemnly declare that the following is true to the best of my knowledge, information, and belief:
 - 1. Counsel for Plaintiff in this matter is the Sullivan Law Firm. As indicated on the complaint, I have appeared as co-counsel for Plaintiff as the LAW OFFICES OF LANCE C. Dahl, PLLC. I have first-hand knowledge of the facts set forth below and am competent to testify thereto.
 - 2. This complaint was filed on May 8, 2014. Defendant Windermere promptly appeared and accepted service as of May 13, 2014. However, for the reasons set forth below, we have been unable to personally serve defendants Sean Stewart or his marital community.

- 3. This litigation concerns alleged defects to a Seattle house purchased by Sean Stewart in November 2011 and sold to Jessica Wubbels in the spring of 2012 after an extensive remodel. According to the records of the King County auditor, Stewart is an active real estate investor. The auditors' records show multiple purchases and sales of single family residences by Stewart personally or through a Stewart's limited liability company, Global Private Equity LLC, in the last three years.
- 4. According to King County records, during the past several years the Stewarts have used the "office address" of 1700 7th Avenue #2100. On occasion, the Stewarts have used a personal residence address of 3315 217th Pl., Sammamish. However, the Sammamish house was sold in January of 2014, and no new residence address has been located.
- 5. The 1700 7th avenue address is a "virtual office" operated by Premier Business Centers. The named tenant is Global. According to the Secretary of State records, Sean Stewart is the only listed member. Mr. Stewart is the registered agent for Global and uses the same 1700 7th Avenue address for this agent's address.
- 6. Several examples of recent purchases and sales from the King County auditors records follow:

5139 SOUTH MEAD STREET, SEATTLE

Purchased by Sean Stewart in November 2011. Statutory Warranty Deed AFN 211103000330. Deed calls for mailing to: Sean Stewart at 1700 7th Avenue, Suite 2100, Seattle, WA 98101. This house was sold to Plaintiff in May 2012.

21606 SE 32ND **PL., SAMMAMISH**Purchased by "Margarette" Stewart in February 2012. Bargain and Sale Deed AFN 20120210001603. Deed calls for mailing to: Margarette Stewart at 1700 7th Avenue Suite 2100 Seattle, WA 98101. This house was sold by Margaret and Sean Stewart in June 2012.

10204 SE 8TH STREET, BELLEVUE

Purchased by Sean Stewart (a married man as his separate estate) in September 2012. Statutory Warranty Deed, AFN 20120921001701. Deed calls for mailing to: Sean Stewart at 3315 217th Pl. NE, Sammamish, WA, 98074. This Bellevue house was sold by Sean Stewart in March 2013.

LAST KNOWN HOME ADDRESS:

3315 217TH PL. NE, SAMMAMISHThis house was sold by Sean Stewart on January 1, 2014. No current residence has been located.

- 7. Between May 9 and May 28, three attempts were made to serve Sean Stewart at his business office during business hours. Mr. Stewart either was absent or declined to come to the reception desk. To date, Mr. Stewart has not responded.
- 8. Clearly, service by mail is as likely or more likely to give actual notice as service by publication. Hence, Plaintiff requests an order approving service by mail in accordance with CR 4d(4). The mailing address will be the same office address that King County Property Records show that both Sean Stewart and Margaret Stewart receive important mail at: 1700 7th Avenue #2100.

I declare under penalty of perjury under the laws of the State of Washington that the foregoing is true and correct.
